

Principles and Practices of Working as a CCTV Operator in the Private Security Industry

Specimen Examination Paper

The specimen examination paper questions contained in this publication are representative of the type of questions used to assess candidates taking the Principles and Practices of Working as a CCTV Operator in the Private Security Industry examination.

Candidates are assessed by a 40 question, 60-minute, multiple choice examination. Candidates have to correctly answer 28 out of 40 questions to pass.
